Dear KY AHEAD Members,

The Kentucky Primaries will be taking place on May 20. While we want to enjoy our Conference, everyone also needs to vote! I just checked with our local County Court Clerk's office and learned that it is a simple procedure to vote by absentee ballot. It requires going to their office with a picture ID, filling out a brief form swearing that you will not be in your local area on May 20, and submitting your vote. I was told this could happen in Fayette County as early as April 21 and continue up until the day we leave, but every County Court Clerk may have different timelines. The Executive Director of National AHEAD, Stephan Hamlin-Smith, has been working on finding affordable liability insurance coverage for AHEAD Affiliate Groups. Many of our Board members have looked into liability insurance over the past couple of years and it has been very expensive. Recently, Stephan worked out a coverage plan for Affiliates that costs \$135.00 per year, as an extended umbrella general liability policy under AHEAD's overall underwriting package. Our Board members have unanimously voted in favor of this offer. We have to respond before 21 April. We will have more information and discussion about this liability insurance coverage for KY AHEAD at our Business Meeting on Tuesday night at the Spring Conference.

Another very important issue we will be addressing at the Business Meeting is the proposed revisions and updates to our By-Laws. Kathy Pendleton chairs this Subcommittee and she will be sending out the draft copy of proposed changes to our By-Laws this week for all members to review prior to the Conference. Members will be asked to discuss and vote on these changes at the Business Meeting on May 20.

RE-TOOLING THE DISABILITY SERVICES TOOLBOX

2008 CONFERENCE SESSIONS:

Tuesday, May 20, 2008

7:30-9:00am Registration

9:00 - 10:30am Keynote Address
With Toolboxes of Self-Determination, What Can We Build Together?
- David Parker

Dr. Parker will define self-determination; discuss why postsecondary services that promote self-determination are important to college students with disabilities; describe the 7 habits of highly self-determined disability service providers; and facilitate an interactive discussion of what we as professionals can build together with attitudes and skills that promote self-determination.

10:30am - 12:00noon Concurrent Sessions

Conducting A Structured Interview - Lisa Besnoy (Commonwealth Ballroom)

This interactive session is designed to provide guidelines and practical resources to conduct a structured interview in the field of Disability Services in the postsecondary environment. The presenter will provide tips for creating a customized structured interview and how to create effective professional relationships with students with disabilities. The presenter will address prevalent mental health disorders and how a structured interview can address issues not always resolved in documentation. Session participants will create a sample outline of a structured interview during the session.

How can the KY Office for the Blind Partner with You?

- Chad Hunt & Mike Hall (Bluegrass Ballroom)

The purpose of this presentation is to build strong working relationships with Disability Coordinators and Post Secondary Education institutions. This session will create awareness of the comprehensive services the Office for the Blind provides its consumers and to Secondary and Post Secondary schools. Topics will include available services provided to students who are transitioning from high school to post secondary school and from post secondary school to employment, as well as accommodation and accessibility services offered.

Interpreter Session: Backseat Interpreting: Making Professional Judgments - De Johnston (Kentucky Ballroom)

Not every situation interpreters find themselves in requires an ethical decision within an interpreting setting. However, we must be aware of our feelings about professional standards and ethics in order to decide with more volition. The world is not black and white; it's varying shades of GRAY. There is no one right answer to many of the decisions interpreters make each day. During this workshop, participants will develop skills in problem solving and decision making, in improving professional judgment, exploring the interpreter/consumer relationship, and the impact of cultural mediation. Leveling the Digital Playing Field: Infusing Tech Proficiency into Existing Service Delivery Models - David Parker

Dr. Parker will present the traditional model of service delivery for college students with disabilities and describe the need for an updated model in the digital technology age. He will demonstrate how the Principles of Universal Design for Instruction can be infused into strategy instruction using the *Learning Technologies Management System* (LiTMS) model. Participants will be guided through a brainstorming session to consider ways to adapt the LiTMS model on their own campuses.

3:00 - 4:30 pm Concurrent Sessions

Veteran Disability Resource Service Providers Share Experiences

- Cathy Patus & Jake Karnes (Commonwealth Ballroom)

This session, presented by disability services veterans with a combined 63 years of experience, is designed for disability services professionals who are new to the field or who have split job duties that include disability services. Topics will include: a brief historical overview of federal legislation and the evolvement of disability services as a profession, the philosophical framework for effective service delivery, an overview of the various areas of responsibility, and sharing of resources that are invaluable to both new and seasoned professionals. Plenty of anecdotal information will be provided along with a touch of humor to assure the audience that each day in the life of the disability services professional brings new challenges and opportunities for learning.

Accessibility Challenges in University Web Environments

- Mandy Eppley & Parker Owens (Bluegrass Ballroom)

How can we take advantage of innovative learning environments and still meet ADA requirements for education? Instructors and faculty publish class content on websites, in online classes, and within Web 2 applications. This slide presentation will address awareness of access challenges in these three specific areas, with an emphasis on standard web accessibility guidelines, and suggestions for making universal design accommodations.

Interpreter Session: Parlez Vous Parlance You? Expanding Your ASL Options - Part 1 - De Johnston (Kentucky Ballroom)

Parlance is a manner of speaking that is natural to native speakers of a language. This occurs, too, in ASL. Deaf people use many phrases and expressions that are seemingly unfamiliar to many Hearing people and Interpreters, i.e. "get it through your head", "I want that after you", "trash talk", to be in your own little world, and those "odd" facial expressions that have meaning, too. This workshop will teach many of these. Participants will understand how parlance is used within ASL, will analyze phrases and expressions used in ASL, and will be able to use them appropriately in context.

Millennials and "New" Disability Law Issues for for College and University Students - Laura Rothstein

The legal response to resolving legal issues applicable to students with disabilities in higher education has not changed substantially in recent years. The enrollment of "millennials" (students who have grown up with technology and the culture that affects their generation), however, has brought new challenges to institutions of higher education. Students who want their companion turtle to accompany them to exams and students who expect instant responses to their emails or cell phone calls requesting unlimited time on exams present interesting new challenges. Combining these behaviors with disability discrimination issues makes life even more interesting. Knowing the legal requirements is only the beginning of developing a proactive approach to serving this generation of students. The session will use a set of hypothetical scenarios to illustrate the current legal framework for examining these issues as well as a discussion of the policies, practices, and procedures that might help to address current situations occurring on campus.
